## APPLICATIONS

### DEADLINES

- Submission of applications ..... until 31<sup>th</sup> July
- Placement results ..... until 7<sup>th</sup> September
- Submission of complaints over results ..... 7<sup>th</sup> to 16<sup>th</sup> September
- Enrolment ..... 7<sup>th</sup> to 13<sup>th</sup> September

### REQUIREMENTS

- Holders of a graduate degree or legal equivalent.

### SELECTION CRITERIA

Candidates will be selected on the following parameters:

- Final grade of the degree with which is applying (50%);

- Previous background relevance and suitability for the master's degree course (50%). The jury assigns each candidate a grade of 0 to 20, based on an analysis of: letter of motivation and curriculum vitae. If necessary, the members of the jury may decide to conduct an interview to all or to some candidates.

Elements to consider: (i) a degree in Law; (ii) for post-Bologna graduates in Law, a bachelor degree corresponding to, at least, 240 ECTS.

- Candidates with a rating lower than 9,5 will be automatically excluded.

## SUBMISSION OF APPLICATIONS (ONLINE)

- Fill the application form (online);
- Payment of the application fee, using the ATM or Paypal (reference given during the submission 51€).
- Online submission of the following documents: motivation letter, *curriculum vitae* (european model), copy of the course(s) certificate(s);
- Candidates conditioned upon the conclusion of the degree must send a school record with the subjects already done and the final grade. Also, a declaration stating the degree, the school, the expected average and the conclusion date.  
They also must send a statement from the Institution of Education where they attend the degree, proving the academic situation.
- Candidates with foreign qualifications must send a school record or a declaration with the final average of the degree.
- Candidates who do not report the final grade average, expected or completed, will be graded with a minimum score of 10 on the 0-20 scale.

**Applications that are not complete with all documents or whose application fee has not been paid will be dismissed.**

- Application fee ..... 51€
- Administrative cost per enrolment (each year) ..... 35€
- School Insurance ..... 3€
- Annual fee of the taught part..... 4.000€  
(annual amount paid in 10 times (1st x 850 € + 9 x 350€))
- Non-taught part (dissertation), one year..... 1.400€

- Extension of the non-taught part (90 days)..... 210€

## MERIT SCHOLARSHIP

### THE FDUNL OFFERS DISCOUNTS ON THE 2<sup>ND</sup> CYCLE FEES FOR THE BEST CANDIDATES

Discount of 30%, if the final average classification is equal to or greater than 17 (on a scale 17/20) or 8,5 (on a scale 5/10).

In the non-taught semester (dissertation) it will be given three merit scholarships: one that corresponds to the total of the tuition fee, which will be awarded to the best grade in the curricular phase, and other two to the second and third best classifications, that will have a reduction of half of the amount.

Students who have graduated on FDUNL have 10% discount on the total amount of the tuition fee.

Discount of 5% over the total amount of the tuition fee, if paid on the registration or enrolment period.

Discount of 25% for members of the Association of Portuguese Judges and the Trade Union Association of Public Prosecution Service Magistrates.

The discount will be applied on the last installment.
